### FaithAction Marks a Decade of the Faith Covenant

# During Faith in Partnership Week 2024

FaithAction celebrated the 10th anniversary of the Faith Covenant during a breakfast event at Westminster, attended by the Faith Minister, Lord Khan of Burnley. The Faith Covenant, designed to foster collaboration between faith organisations and local government, has played a crucial role in supporting communities over the past decade.

"I am determined to maintain an open-door policy and listen. I want to engage with as many faith leaders as possible, as faith-based organisations play a vital role in communities, providing support to people of all faiths and none."

The meeting was the culmination of several meetings held during Faith in Partnership Week 2024.

During the week, we introduced the 'Faith for a Safe Start' toolkit, designed to help faith organisations collaborate with the NHS to improve maternal health outcomes for ethnic minority communities.

An event was hosted at the House of Lords by Rt Rev Dame Sarah Mullally, the event featured speakers from NHS England, Alive Church Lincoln, the British Islamic Medical Association, and The Royal College of Midwives.

"COVID highlighted existing health inequalities. Deprived communities face barriers to accessing healthcare, and faith groups are constantly caring for their communities. My goal is to create systematic ways for faith to be involved in addressing these disparities."

Later in the week, FaithAction held an online Faith Covenant Forum, bringing together representatives from local authorities that have signed the Covenant. During the forum, we presented findings from the 'What Matters to Us' survey, which captured faith leaders' priorities for the newly elected government.
